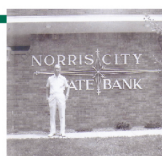

The selected name "Banterra" reflects "Bank of the Earth" (1983). Further growth occurred through acquiring banks in Southern Illinois. (Christopher, 1984; Marion, 1985; Norris City, 1986; and McLeansboro, 1989).
