Banterra Lobbies Are Now Open

BANTERRA CONTRIBUTES \$180,000 TO HEALTH CARE FACILITIES AND REGIONAL COLLEGE.

In honor of the pandemic challenges endured by health care and education facilities, as well as the particular fundraising campaigns by these organizations, **Banterra** recently contributed a total of \$180,000 to three key Southern Illinois organizations. Southern Illinois Healthcare (SIH) received \$100,000 commitment from **Banterra** for expansions to SIH Cancer Institute (Carterville, IL), Ferrell Hospital (Eldorado, IL) received \$50,000 for their new addition and Rend Lake College Foundation (Ina, IL) received \$30,000 for their renovations to the Campus Learning HUB.

Banterra's donation to SIH included naming rights for the infusion center family waiting area in the new expansion of SIH Cancer Institute. In addition to \$50,000 dedicated for the needs of SIH Cancer Institute, a remaining \$50,000 was committed for SIH sponsorship - with \$20,000 from recent commitments and \$30,000 for future sponsorships over next five years.

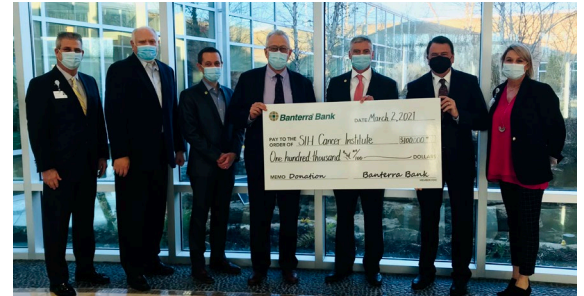
SIH is one of the region's largest employers and **Banterra** has established a strong partnership with them over the years. Their commitment to providing quality health care service to an area that benefits so many residents in **Banterra's** footprint is greatly appreciated.

In addition to SIH, **Banterra** provided a \$50,000 donation to Ferrell Hospital to secure a naming rights agreement as part of the hospital's new, completed 55,000 square-foot expansion. **Banterra** will have the naming rights to the new public courtyard, located next to the new waiting room area. Ferrell Hospital completed and opened the \$34-million expansion in December 2020, and the addition more than doubled the hospital's previous size.

Ferrell Hospital is located in Eldorado and also where **Banterra** employs several area residents as part of the bank's 470+ employee base. Because of this, with Ferrell Hospital providing an essential service to so many community members of this area, **Banterra** wanted to do its part in supporting the critical growth need of the hospital.

To further support their communities, **Banterra** donated \$30,000 to Rend Lake College (RLC). The funds support RLC's Campus Learning HUB campaign and will be used for a library expansion that provides offerings to both the students and visitors.

Rend Lake College is a nationally ranked college in Southern Illinois with campuses located at Ina, Mt. Vernon, and Pinckneyville. RLC's mission is to provide open access to lifelong education across cultural and economic boundaries to a diverse student population. The college has positively impacted countless students and community members for over fifty years and will continue to do so with generous support from companies like **Banterra**.

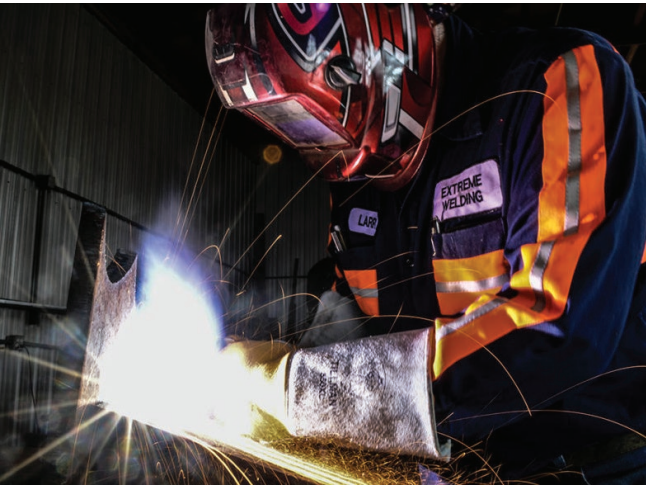
When and where did your business start?

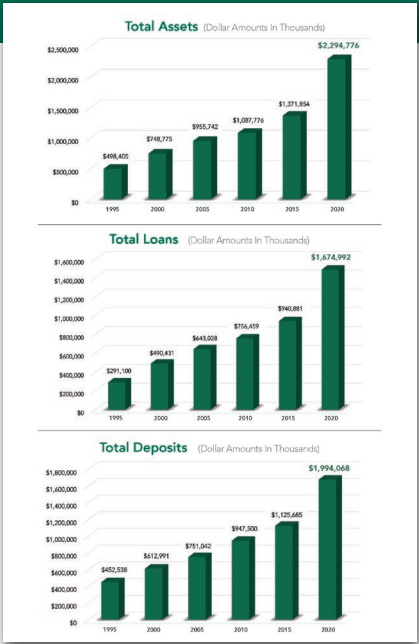
BANTERRA HAS ANOTHER RECORD-SETTING YEAR IN 2020

NEW BANTERRA WEBSITE LAUNCHING IN APRIL 2021

REDESIGN & BANTERRA.COM BECOMES BANTERRA.BANK

Banterra will be launching a brand-new, modern website in 2021. Along with the fresh new look, Banterra's website will feature upgrades including a fully searchable site, live chat with customer care and online appointment scheduling.

With our new responsive site, Banterra.com will also be switching to Banterra.bank, to provide customers even more safety and security. What sounds insignificant is meant to show visitors that the bank is really a bank at a time when online scams continue to soar. Dot-bank extensions are exclusive and unlike dot-com, only banks and other like vendors can get the extension for their URLs. Not only is there a vetting process for applicants, but banks with dot-bank extensions must also comply with registry policies on an ongoing basis.

Banterra.bank is scheduled to launch mid-April 2021.
